DESIGNED TO IMPROVE AIR QUALITY, MANAGE STORMWATER, AND PROVIDE SHADE, THE URBAN AIRSHED REFORESTATION PROGRAM HAS PLANTED 7,000 TREES ALONG CITY STREETS AND IN URBAN PARKS. THE RENAISSANCE TREES PROGRAM IS A COMMUNITY-BASED REFORESTATION EFFORT THAT BEGAN IN 2006 IN THE CITY OF NEWARK AND SURROUNDING NORTH JERSEY CITIES. CREATED TO INCREASE THE TREE CANOPY, IMPROVE THE ENVIRONMENT, AND ENHANCE THE QUALITY OF LIFE IN NEW JERSEY'S LARGEST CITY, THE RENAISSANCE TREES PROGRAM HAS PLANTED 3,500 TREES.
